Location:

The LifeFest Kapalua Farmer's Market will be located at The Ritz-Carlton Kapalua, Group Entrance.

Dates and Times:

Saturday & Sunday, September 9 & 10, 2006
10:00 a.m.- 6:00 p.m.

Exhibit Space:

The Farmer's Market will be located at The Ritz-Carlton, Kapalua, in the highly trafficked entrance area of LifeFest Kapalua's lecture rooms. Each exhibitor space consists of two (2) 6-foot, skirted tables with two (2) chairs. Exhibitor's display must be able to fit on the tables or in their display area.

Exhibitors should bring their own displays, products, cash boxes, credit card processors, extension cords, tape, supplies and other materials as appropriate. You are also welcome to bring your own banner up to 6' wide and 2' high to hang on the front of the table. Banners should be taped to the table. Screws, nails, staples or other fastening devices that may damage the table, linens or walls are not permitted.

Tents, canopies, extra tables or chairs, poles and other large display items are not permitted without prior approval.

Electricity:

Please let us know when you submit your application if you require electricity as access to power is limited.

If you require electricity, please be sure to supply your own extension cords, tape (to secure any loose cords for safety), surge protectors, etc.

Other:

All confirmed exhibitors will receive their space assignments, map, set-up and break-down instructions, and other important information by August 2006.
